NonProfits' United Message From Our CEO

Due to the diligence of our Membership & NPU staff, we've been able to guide the organization through difficult times by not just reacting to change but also by anticipating & preparing for it.

Almost everybody enjoys a good comeback story-the phoenix rising from the ashes, the team in last place that ends up taking the pennant, the detective who comes out of retirement to solve a case that baffles the department.

Members of NonProfits' United began to live our own comeback stories as 2022, a year defined by transition, ended on a grace note.

Employees who had gone missing during the COVID crisis started to come back to the workplace, drawn by jobs with purpose. They began to return even though they could have made as much money collecting unemployment insurance or by working in the fast-food industry. Some had gone to companies such as Amazon, which offered benefits a not-for-profit organization either struggles to provide or simply can't.

In the fourth quarter of 2022, we also began to see growth return to our sector. This started to occur despite very real challenges-such as the auto industry's cost increases and lack of parts (due to the worldwide disruption of the supply chain), as well as the decreases in premiums for our workers' comp insurance practice. The numbers describe the landscape: NPU has 202 Members in its auto insurance program and 148 on its workers comp side-but, significantly, we have 60 Members that currently use both programs, a number we hope to see rise as the economy smooths itself out.

"Transition" may be the key descriptor of 2022. During those 12 months we saw the previous two-year trend of the "remote" employee take on permanence, as 50 percent of NPU Members' workforce opted for a hybrid combination of home and office or just home as office.

We saw funding for the majority of notfor-profit programs continue to stagnatein 2010, state and federal money had funded about \$10 per day per client; in 2022, that amount remained the same,



despite inflation and the inevitable rise of the cost of living. Yet by year's end, we saw glimmers of possible improvement on the funding horizon-and we hope that by the close of 2023, the overall situation will have improved.

In my message last year, I was pleased to share that despite the challenges of the pandemic and flat financial assistance, NPU's membership had held steady. I'm just as pleased to report that we remain united, strong, hopeful and, perhaps most important, agile. Due to the diligence of our Membership and NPU staff, we've been able to guide the organization through difficult times by not just reacting to change but also by anticipating and preparing for it.

I thank you for your continued belief in your mission and ours. To our board of directors, trustees and to our loyal staff members, I can firmly say that together we are indeed stronger.

My gratitude to you all.

We help nonprofits reduce premiums and loss-related expenses, which allows our member-owners to focus greater resources directly on their missions.





Our Workers' Compensation Group is the first of its kind for California nonprofits- a self-insurance group for the health and human services company.

Founded in 2004, the group is evaluated twice annually through actuarial analysis to certify the pool is at the central estimate/ undiscounted expected level-confirming the group's presence within regulations mandated by the Department of Industrial Relations, Office of Self-Insurance Plans.




